

INVITATION FOR BIDS

“Southern Fulton Elementary School Lighting Upgrade Project”

The Southern Fulton School District will receive sealed bids for the “Southern Fulton Elementary School Lighting Upgrade Project” at the Southern Fulton Elementary School’s District Office, 3072 Great Cove Road, Suite 100, Warfordsburg, PA 17267, until 9:00 am. Monday, May 21, 2018 at which time and place, all bids will be publicly opened and read aloud. Bids must be in a sealed envelope addressed to the Southern Fulton School District, Attn: MaryAnn Johnson, Board Secretary, 3072 Great Cove Rd, Suite 100 Warfordsburg, PA 17267 and clearly marked “Southern Fulton Elementary School Lighting Upgrade Project:”.

The project consists of furnishing the labor to retrofit approximately (897) T12 fluorescent light fixtures with direct wired LED Bulbs and retrofit approximately (160) existing 2’ x 2’ 4 pin fluorescent light fixtures with new direct wired 4 pin LED Bulbs. Bulbs and related material will be supplied by the district. There will be a pre- construction meeting May 14, 2018 at 9:00 a.m. at the Southern Fulton Elementary School’s, District Office located at 3072 Great Cove Road, Suite 100, Warfordsburg, PA 17267,.

Compliance with Act 127 of 2012 requiring all contractors and subcontractors to use e-Verify for verification of employment eligibility for all employees will be required. Verification form shall be provided to the Southern Fulton School District as a precondition of being awarded a contract.

In addition to the Equal Employment requirements of Executive Order 11246 regarding discrimination, the Contractor must establish a 6.9 percent goal for female participation and a 1 percent goal for minority participation in his/her aggregate onsite construction workforce for contracts in excess of \$10,000.

The Southern Fulton School District reserves the right to reject any or all bids and to waive any or all defects, errors, omissions, irregularities or informalities of any bid.

The Pennsylvania Prevailing Wage Rates applies to projects in excess of \$25,000.

Awards shall be made only to responsible bidders that possess the potential ability to perform successfully under the terms and conditions of this procurement. Consideration shall be given to such matters as bidder integrity, compliance with public policy, record of past performance and financial and technical resources when determining responsibility.
